CALL TO ORDER

The meeting of the Boulder City License Board was called to order at 8:30 a.m., Thursday, October 7, 2021, in the Council Chamber, City Hall.

PUBLIC COMMENT

No comments were offered and the Public Comment period was closed.

1. For possible action: Approval of the August 19, 2021 Business License Liquor Board Meeting Minutes:

Motion: Approve the minutes of the August 19, 2021 Business License Liquor Board meeting

Moved by City Clerk McKay; seconded by City Attorney Walker; unanimously APPROVED.

2. For possible action: Approval of a Class D-1 Package Limited Liquor License for Dam Good Pasties dba Cornish Pasty Co.

A staff report had been submitted by Utility Billing Supervisor Prestwich and included in the October 7, 2021 Business License Liquor Board packet.

Utility Billing Supervisor Prestwich provided a brief overview of the staff report noting approval of the license would allow the sale of beer or wine in sealed

package for consumption off premise. He said the applicant would have 10 plus beers on tap including local, seasonal, and imported British beers. He noted the applicant met all the requirements pending approval of business license and following conditions: the licensee cannot display or advertise such liquor for off-sale purchase by patrons, and any sales must be incidental to the on-premise sale and consumption of alcoholic beverages.

Motion: Approve Class D-1 Package Limited License with staff's recommended conditions.

Moved by City Attorney Walker; seconded by City Manager Tedder; unanimously APPROVED.

City Attorney Walker clarified her original motion should have included staff's recommended conditions. City Manager Tedder seconded the amended motion. The motion with conditions was unanimously APPROVED.

3. For possible action: Approval of Liquor license change of location for Marisco's El Soto Loco

A staff report had been submitted by Utility Billing Supervisor Prestwich and included in the October 7, 2021 Business License Liquor Board packet.

Utility Billing Supervisor Prestwich provided a brief overview of the staff report noting the business has moved locations. He said the applicant hold a business license and was in good standing. He said since the preparation of the staff report, the applicant received final permits from the Southern Nevada Health District.

Motion: Approve liquor license change of location for Marisco's El Soto Loco

Moved by City Clerk McKay; seconded by City Manager Tedder; unanimously APPROVED.

4. For possible action: Approval of a Class G Special Event Liquor License for the Nevada Beer Project and Boulder Dam Brewing's Fallout Festival
