Evaporative Cooler Rebate Program Requirements

1. To be eligible for a rebate, the unit must supplement an existing refrigerated air conditioner (serving living space).
2. A completed rebate application form must be submitted within 60 days of the installation date.
3. A dated contractor invoice, dealer invoice, or proof of purchase will be required as proof of installation date.
4. The rebate is based on \$50 per 1,000 CFM.
5. Residential purchasers of qualifying evaporative coolers may be subject to an on-site inspection by a Boulder City representative to verify installation and product information.
6. The rebate only applies to new evaporative cooler installation and not an existing installation or upgrade.
7. Residence must have a minimum of one and one half tons of existing refrigerated air conditioning.
8. Submit all documents described in the Submittal Checklist below.

Submittal Checklist

- The Applicant submits this application, complete, to Public Works for approval
- Evaporative Cooler paid invoice or receipt with purchase date
- A copy of the last utility bill
- Pictures of the new unit installed
- Pictures of the installation location *before* installation
- Picture of the service tag including the model #
- Picture showing the Yellow SEER Rating Sticker

This application will **NOT** be accepted unless all documents are included and all boxes are checked.
