Eldorado Valley Fire Hydrant Meter Additional Requirements

1. Water pressure is about 170 psi.
2. Must use a stand tank at minimum with an air break or backflow device.
3. Must not constantly turn the fire hydrant on and off. Pressure will destroy fire hydrant.
4. Hydrant should be in the fully opened position.
